APPROVAL OF MINUTES: On a motion by Director Fudala and seconded by Director Cothran, Director Hill abstained since he wasn't present for that meeting, the minutes were passed as presented vote being 3 ayes 1 absent and 1 abstained.

STAFF REPORTS: Correspondence, County monthly report and monthly bank statement. The financial statement was read. We received a packing slip for the spraying material and this bill will be paid when the invoice is received by mail. We have our cold patch for pothole filling and that bill has not been received as yet. The secretary brought up that both Debi Caldwell and Debbie Fudala's Director seats will end on December 1, 2015. We will post a notice in January for volunteers to fill these seats until the November 8, 2016 election.

ROAD MANAGERS REPORT: Hooley submitted 2 revised bids for Riata Way down by the mail boxes to lay road base, pack and roll on edges of asphalt where cars pull off waiting for the school bus cost being \$1900 and one for ditch cleaning on Jaquima the entire road for \$1700, both bids totaling \$3600. On a motion by Director Hill and seconded by Director Cothran the Riata contract for \$1900 was approved with a Vote of 4 ayes and 1 absent, Hill, Cothran, Caldwell and Fudala. On a motion by Director Caldwell and seconded by Director Fudala the Jaquima contract for \$1700 was approved with a vote of 4 ayes and 1 absent, Hill Cothran, Caldwell and Fudala.
